## General Information

The Candidate Policy Manual outlines policies and procedures of the Candidate for Designation program. It is a companion document to Regulation No. 1, Admission to General Candidacy and MAI Membership, Regulation No. 2, Admission to Residential Candidacy and SRA Membership, and Regulation No. 3, Admission to General and Residential Review Candidacy and AI-GRS and AI-RRS Membership.

## References to Candidacy

Each Candidate of the Appraisal Institute:

- shall only be referred to and shall only refer to himself or herself both orally and in writing as a:
  - “Candidate for Designation, Appraisal Institute”;
  - or by such other terminology that the Appraisal Institute may permit.
- may use the above terminology on business cards, letterhead, web sites and other publications;
- shall use the above terminology only in conjunction with the full name of an individual and not in connection with the name, logo or signature of any firm, partnership or corporation;
- may not abbreviate the above terminology with initials or otherwise, or convert them to an acronym;
- may **not** use or refer to a specific Appraisal Institute designation that the Candidate does not already hold, nor include the above terminology under a heading concerning professional designations (the above terminology may be included under a heading concerning professional associations);
- may **not** use the terminology “Member, Appraisal Institute” if the individual does not already hold an Appraisal Institute designation; and
- may **not** use the terminology “Candidate Member.”

## Required Time Period

“Required Time Period” shall mean the four (4) year period of time in which Candidates must complete the requirements for Designated Membership.

## Maximum Length of Candidacy

Except where otherwise provided, a Candidate must complete the requirements for designated membership within four (4) years from the date of admission to Candidacy.

If a Candidate fails to complete the requirements for designated membership within the Required Time Period, that individual may request to enter a **new** Required Time Period (if eligible). When a new Required Time Period is requested, the individual will be subject to the requirements in effect on that date. The Candidacy of individuals who are no longer eligible to enter a new Required Time Period shall be terminated and the individual will be entered into the Practicing Affiliate category.

## Candidate Termination [Required Time Period]

If a Candidate fails to complete the requirements for membership within the Required Time Period and does not receive a new Required Time Period, the individual's Candidacy will be terminated. Candidates terminated for not receiving a new Required Time Period will be moved into the Practicing Affiliate category.

## Candidate Advisor

Candidates will have the option to select an Appraisal Institute Candidate Advisor.

## AI Equivalencies

If the ADQC determines that one (1) or more courses or examinations offered by an accredited college, junior college, community college, or university are equivalent to one or more Appraisal Institute courses and examinations required for membership, an applicant for admission to Candidacy who has completed such equivalent course(s) or examination(s) shall be deemed to have completed the appropriate course or examination requirement for membership.
